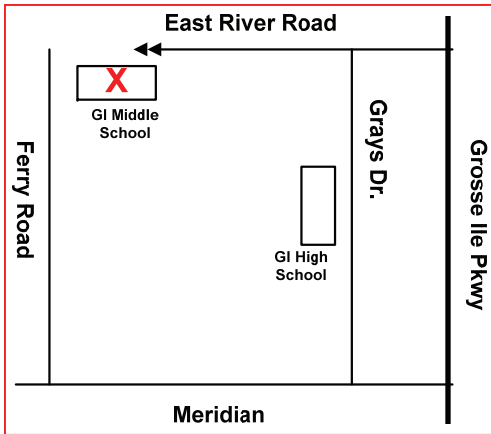
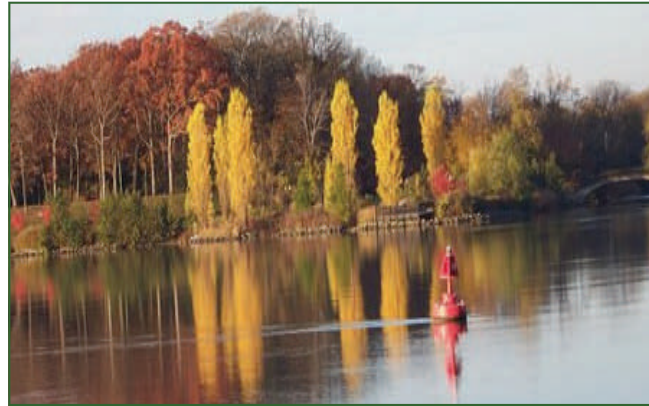


Weekly Runs:
